


Kemmy as Treasurer

Chair Report – Overview of activities from Oct 20-21

What a strange year 2020/2021 has been, we have to limited our PTA meetings and shift to zoom meetings. The unprecedented events of pandemic has left many of us vulnerable with financial constraints. We also could no longer run social event such as bake sales, raffles etc. This has affected the fundraising we could do over the pandemic. Despite all this we put our efforts towards a successful crowd funder and we still managed to raise a significant amount of funds.

The most significant fundraising was through Crowd funding with the help and support of Ms Moya Lothian-McLean who's influential on twitter. We managed to raise over £5000 in 24 hours after her tweet went viral & after Ian Wright retweeted her. Thanks go to who Ms Bougeard who told Moya about what we were trying to do. Through the Crowdfunder we raised in excess of £5,000 to make sure that every child had access to a laptop at home during the pandemic. With this money the school

invested in Chromebooks and these were given out as a loan scheme to families. Thanks to Sueann this also resulted in some positive press for the school in the form of an article in South London Press.
